# A.1. Current Book Project

## Democracy is a Team Sport: How Political Parties Transformed the American Republic

The U.S. Constitution has a number of oft-recognized democratic defects. I argue that, given the difficulty of amending the Constitution, political parties have instead systematically addressed these defects, sometimes exploiting them but more often correcting them. American politics is now chiefly organized by parties, rather than the geographic, federal organization imagined by the founders, opening otherwise unavailable avenues of representation and accountability.

I am currently persuing a book contract with several interested presses.
